INTERNET PRIVACY & COOKIES POLICY



Premier Care Nursing Agency are committed to safeguarding and preserving the privacy of all visitors; the following Policy will explain what happens to any personal data that is provided to Premier Care, or, that Premier Care has collected whilst our site is being visited and how cookies are used on the website.

Cookies

Cookies provide information regarding the computer used by a visitor. Cookies may be used where appropriate to gather information about your computer in order to assist us in improving our website.

We may gather information about your general internet use by using the cookie. When used, these cookies are downloaded to your computer and stored on its hard drive. Such information will not identify you personally; it is merely statistical data which does not identify any personal details whatsoever.

Collected Information

In maintaining and running of our website the following may be collected and processed: -

- Information about the use of our site including details of visits such as pages viewed and the resources that have been accessed. Such information will include location data and other communication data
- Information provided voluntarily e.g. when someone registers for information
- Information provided to communicate with Premier Care by any means

Use of Information

Information collected is used by Premier Care to provide its services. In addition to this the information may be used for one or more of the following purposes:

- To provide information that has been requested relating to our products and services
- To provide information relating to other products that may be of interest. Such additional information will only be provided with consent to receive such information
- To provide information of any changes to our website, services or goods and products

If goods or services have previously been purchased from Premier Care we may provide details of similar goods or services, or other goods or services that may be of interest.

Details will never be given to any third parties to use data to enable them to provide information regarding unrelated goods or services.

Storing Personal Data

In operating our website it may become necessary to transfer data that we collect to locations outside of the European Union for processing and storing. By providing your personal data to us, you agree to this transfer, storing and processing. We do our utmost to ensure that all reasonable steps are taken to make sure that data is stored securely.

Unfortunately the sending of information via the internet is not totally secure and on occasion such information can be intercepted. Premier Care cannot guarantee the security of data that is chosen to be sent to us electronically, sending such information is entirely at the senders own risk.

Disclosing Information

Premier Care will not disclose any personal information to any other party other than in accordance with this Privacy Policy and in the circumstances detailed below:

- In the event that we sell any or all of our business to the buyer
- Where we are legally required by law to disclose personal information
- To further fraud protection and reduce the risk of fraud

On occasion we include links to third parties on this website. Where we provide a link it does not mean that we endorse or approve that site's policy towards visitors' privacy. Their own privacy policy should be reviewed before any personal data is sent to them.

Access to Information
